Agenda Item 1. Call to Order/Pledge of Allegiance/Introductions/ Public Comment

The meeting of the Basin Technical Advisory Committee was called to order by chair Thomas Crowley, at 1:31 p.m. via Zoom.

Agenda Item 2. Approval of Minutes.

A. Approval of the Minutes of the April 4, 2022, meeting.

Jeff Noelte moved to approve the minutes of the April 4, 2022, meeting, Steve Miller seconded. The summary notes were accepted with no comments.

Agenda Item 3. New Business

A. Preliminary Regional Annual Water Supply and Demand Assessment

Matt Howard commenced his update by providing a timeline leading up to the annual assessment requirements and provided an overview of the process, tables and findings. Mr.Howard highlighted all retail agencies needed to complete their own assessment, as the state wants to collect as much data as possible to capture the current demand. The retail agencies provided feedback on how the process and methods used to submit the data.

No action was needed, item was received and filed.

B. Discussion of Regional Water Demand Trends

Adekunle Ojo introduced the item by asking what the BTAC thought about the percentage change in water consumption in March of 2022 and pointed out the population decreasing over the last decade.

Mr. Ojo pointed out if you look at the baseline the State is using and look from July 2021, conservation is taking place in our region. Part of the reason these savings are nowhere close to the 15% voluntary reduction the Governor is asking for is that after the last statewide drought was declared over in 2017, many of our retailers kept their restrictions in place due to the continuing local drought. Therefore, many water users in this area have kept their water use lower than other parts of the State, making it very difficult to cut back drastically at this time. The key takeaway Mr.Ojo highlighted was how retail agencies continue to save water, as all agencies significantly reduced GPCD below their 2015 and 2020 targets.

Mr.Ojo explained the opportunities vary from one retail agency to another. The gallons per capita per day is very low; while the average for the City of Colton is 88, the average is misleading because the typical residential customer there uses less than 50 gallons per day. In addition, a retailer such as Yucaipa Valley Water District is largely residential and provides recycled water to many of its commercial and institutional customers, therefore its conservation approach may be different from the City of Redlands and City of Colton with more commercial and institutional customers

No action was needed, item was received and filed.

C. Future of Consumer-Empowered, Smart Agency Water Management by Subeca

John Soulliere, of SUBECA commenced his presentation by providing an overview of Subeca. Founded in 2008, the company was founded in 2008 with a focus in HOA irrigation, and commercial/industrial metering intelligence.

The focus of the presentation was to have a discussion about smart water, and how agencies can use technology to improve their organizations to comply with all the mandates from the state and to the empower our customers to make smarter choices. Mr.Soulliere provided a comparison of conventional conservation tools vs. Smart water management technology. The technology-based systems are able to surpass the conventional conservation tools capabilities.

The future of smart water management networks was addressed, this technology including Internet of things (IoT), Smart water networks, and Long Range Wide Area Network (LoRawan) data can be provided to utilities and consumers so they can become partners in water use efficiency while optimizing agency/city operations.

Mr.Soulliere concluded his presentation by proving Subeca's Smart Network example to think outside the meter box and highlighted Subeca believes the future of sustainable and holistic water management will come from greater access to water use data through wireless IoT devices and networks. It is designed to leverage a smart water network that manages anything and everything water.

No action was needed, item was received and filed.

D. Status Update on SWP Supplies for 2022

Adekunle Ojo commence the status update by noting the state water allocation hasn't changed and highlighted the region is not as dependent on the state water supplies, as some other part of the state. This year we didn't use all the supplies available to all last year, so we carry over some of those supplies to go to a year like this.

Matt Howard added, as agencies near the allotted amount, they would be receiving a notification from the operations staff letting them know. Operations wants to ensure they are keeping track of the allotted number.

No action was needed, item was received and filed.

Agenda Item 4. Old Business

A. Report from the Engineering Subcommittee

Matt Howard provided the update; two items were discussed as part of the Engineering Subcommittee from the USGS. One regarding the flow across the Rialto Colton fault for the barrier and the study they recently completed on Valley districts behalf. The other item covered was as a sensitivity analysis on the Yucaipa Integrated hydrologic model.

B. Report from the Water Conservation Subcommittee

Jennifer Ares provided feedback from the May 23 Water Conservation Subcommittee meeting. During the meeting, items addressed were the large landscape water efficiency program, the conservation emergency regulations and the supply and demand assessment that all the retailers have submitted. The Subcommittee addressed drought messaging and what each agency is doing.

The Inland Solar Challenge event, was discussed. Despite the constraints from the pandemic and challenges faced the event was incredibly successful. Ms. Ares commended Devin Arciniega for her leadership in leading the successful completion of the event.

Shavonne Turner highlighted the Large Landscape program, Prop 1 Round 2; Valley District signed the support letter for that program being led by IEUA, this program will focus on assisting sites with full assessment as well as identifying areas where water savings can be achieved and ways to be more efficient.

C. Report from the Project Review Subcommittee Greg Herzog had no report for the meeting.

Public Comment

Mr.Gil Navarro from the community, requested an item be added to a future BTAC item where Valley District discusses water conservation, specifically with septic tanks.
