VERIFICATION OF EXTRACTIONS
FROM THE RIVERSIDE BASIN
AREA IN RIVERSIDE COUNTY
FOR THE BASE PERIOD 1959 THROUGH 1963

INTRODUCTION

The settlement of the case of the Orange County Water District, Plaintiff, vs. City of Chino, et al, Defendants, being Case No. 117628 in the Superior Court of the State of California in and for the County of Orange, made necessary a settlement of the case of Western Municipal Water District of Riverside County, et al, vs. East San Bernardino County Water District, which was settled by Stipulated Judgment in Case No. 78426, entered in the Superior Court of the State of California in and for the County of Riverside, on April 17, 1969.

In accordance with this judgment, that portion of the Riverside Basin lying southerly of the Riverside County Line in Riverside County and terminating at Riverside Narrows has been delineated as the Riverside Basin Area within Riverside County, also commonly called Riverside Basin South. This area is shown on Appendix "A" of the judgment and is also shown upon a small scale map which appears on Page 124 of this volume.

Paragraph IX of the judgment, entitled "Extractions From the Portion of Riverside Basin Area in Riverside County Which is Tributary to Riverside Narrows," in subparagraph (a), recites as follows:

"The average annual extractions from the portion of the Riverside Basin Area in Riverside County which is tributary to Riverside Narrows, for use in Riverside County, for the five-year period ending with 1963 are assumed to be 30,044 acre feet; the correct figures shall be determined by the Watermaster as herein provided."

In compliance with the directions contained in the judgment, as stated in the quotation immediately above, it was necessary for the Watermaster to verify all of the extractions from Riverside Basin South.

In making the verification, the Watermaster first obtained from the official records of the State Water Resources Control Board the extractions from individual wells and points of surface diversions from Riverside Basin South. The average annual extractions for the five-year period ending with the calendar year 1963 were tabulated by individual wells and surface diversions, with totals for each extracting entity. The pumping equipment and/or diversion facilities and methods of measurement at each individual well and/or point of surface diversion were inspected by the

Watermaster representatives.

The offices of the major extractors were visited and the methods of reduction and tabulation of individual measurements from which the water quantities were taken for the annual filings with the State Water Resources Control Board were inspected and reviewed.

During the work of verification, it was found that there was a total of 115 individual extractions upon which filings had been made, and 6 non-filers as well as 2 late (correction) filings.

The results of the Watermaster's verification are shown on individual sheets for each extraction, numbered Page 1 through Page 123. These sheets have been summarized in Table No. 1 and Table No. 2.

Table No. 1, consisting of twenty pages, summarizes the water production by owner in the Riverside Basin South for the period 1947 through 1970. The table was compiled by the use of the annual filings of extractions made with the State Water Resources Control Board and includes the recordation number of each filing and the State well number of the well from which the extractions were made. During the five-year Base Period 1959 through 1963, where the verification differed from the filed extractions, the filed extractions are enclosed in parenthesis and the verified extraction is typed directly above. The verified extractions made by owners who had not filed with the State Water Resources Control Board and the late filings have been added to the total filed and verified extractions as shown on Pages 17, 18, 19 and 20. Throughout the years, well ownerships have changed hands and where this has occurred, the name of the new owner is shown in parenthesis adjacent to the name of the former owner.

Table No. 2, consisting of sixteen pages, shows the water production by well and owner for the five-year Base Period ending in 1963 and the five-year Base Period average. The names of new owners are shown in parenthesis adjacent to the former owners as in Table No. 1. The extractions by owners who have not filed with the State Water Resources Control Board and the late filings have been included on Pages 14 and 15.

Included in this volume is an index by State recordation number and also by State well number.

The total verified extractions for the Riverside Basin Area within Riverside County for the five-year Base Period ending in 1963 is as shown in the following tabulation:

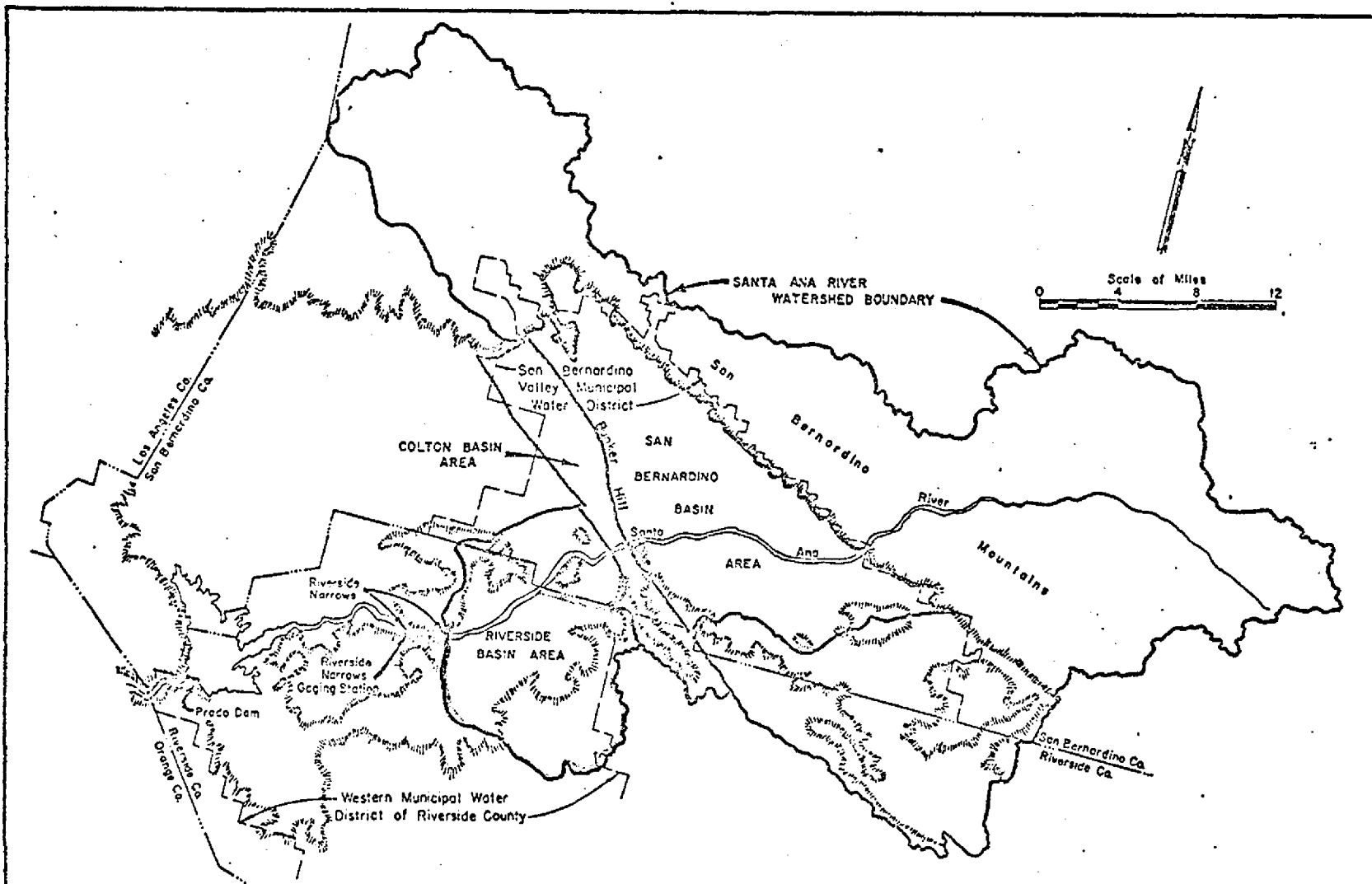
