Congressional Outlook 2021 / Federal Legislative Update

- Appropriations
 - Seven Oaks Dam Report Language
 - Cooperative Endangered Species Conservation Fund (Section 6) funding
- Authorizations
 - "Expedited Completion" language for Seven Oaks Dam Authorization in WRDA
- Both in end-of-year spending bill / coronavirus relief legislation enacted in December

- Slow Organization of the 117th Congress
 - Senate (48 Democrats + 2 Independents / 50 Republicans)
 - Georgia Runoffs
 - 50/50 Power Sharing Agreement
 - Impeachment Trial
 - Committee Changes (Democrats took over in late January), new assignments delayed
 - Feinstein no changes (but didn't take over Judiciary as Chair)
 - Padilla EPW, Homeland Security, Judiciary, Budget, Rules
 - Hired Feinstein staffer (Josh Esquivel) as Legislative Director
 - Hired House Leadership for Environmental Posts

- Senate
 - Confirmations
 - No Dates for Interior floor consideration (historically lags / has been reported out of Committee)
 - No Bureau Commissioner
 - Deputy Commissioner is Camille Touton
 - Office of Water and Science Veteran / T&I / ENR
 - EPA 's Regan Could be Confirmed this Week
 - All "major" nominations likely to require cloture moving forward
 - History: some may be withdrawn (OMB)
 - Consideration of at least two nominees this week

- Senate
 - Consideration of reconciliation package just completed
 - Nominations to continue
 - No announcement on next legislative undertaking

- House (221 Democrats, 211 Republicans, 3 Vacancies)
 - New Committee Ratios
 - Continuing Allowance for RemoteVoting
 - Some Republicans are now using proxy voting
 - Schedule Changes early this year to Allow for Budget Reconciliation
 - Our Delegation:
 - Obernolte: Natural Resources, Science, Space & Technology, Budget
 - Natural Resources authorizing projects
 - · Aguilar and Torres: remain on Appropriations

- Budget Resolution Reconciliation
 - Used for \$1.9 Trillion Spending Bill
 - Likely to be passed by Wednesday
 - Will likely be P.L.117-2 (only second bill enacted)
 - Includes state and local support \$350 billion
 - No special districts language
 - Replenishes the Coronavirus Relief Fund still a target for Garamendi (has reintroduced legislation)
 - Misc. Provisions
 - \$50 million for EPA Clean Air Grants for health disparities outcomes
 - \$4.5 billion for HHS for Low-Income Home Energy Assistance Program

- Notable bill introductions / reintroductions
 - WIIN Act Extensions California Water Provisions
 - Reintroduced by CA Republicans
 - Special Districts Provide Essential Services Act
 - Reintroduced by Garamendi (D-CA) in the House
 - Reintroduced by Sinema (D-AZ) in the Senate
- Filibuster to Remain
 - Democrats had openly discussed eliminating
 - Joe Manchin (D-WV) and Krysten Sinema (D-AZ) don't support changes

- Appropriations
 - Earmarks Return has been announced
 - House appropriations likely to aggressively focus on climate change / resiliency
- Infrastructure
 - Talk of FY22 budget resolution for another reconciliation package (growing more unlikely)
 - FAST Act (Surface Transportation Bill) and Flood Insurance extension expire on Sept.
 30
 - Could be the catalyst for larger infrastructure bill



Water Resources Development Act (WRDA)

- Long history going back to the Water Supply Act of 1958
- Initial Water Conservation Reconnaissance Study started in 1986
- •Several studies, agreements, and water rights applications later efforts stalled in the mid-2010's
- New opportunity to collaborate to realize water conservation goals for Seven Oaks Dam that have been in process for over 35 years
 - Rep. Norma Torres (D-CA) carried language in report accompanying the Energy and Water Appropriations Bill,2021
 - Current, final legislation was incorporated into H.R. I33, the Consolidated Appropriations Act,
 202 I
 - Congressman Pete Aguilar (D-CA) submitted the request to incorporate request to study feasibility of water conservation on behalf of Valley District
 - Chairwoman Grace Napolitano (D-CA): Chairwoman of the Water Resources and Environment Subcommittee appeared to support request

WRDA Language:

SEC.202.EXPEDITED COMPLETIONS

- (a) Feasibility Reports: The Secretary shall <u>expedite the completion of a feasibility study</u> for each of the following projects, and if the Secretary determines that the project is justified in a completed report, may proceed directly to the preconstruction planning, engineering, and design of the project:
- (20) Project to modify the Seven Oaks Dam, California, portion of the project for flood control, Santa Ana River Mainstem, California, authorized by Section 401(a) of the Water Resources Development Act of 1986 (100 Stat. 4113; 101 Stat. 1329-111; 104 Stat. 4611; 110 Stat. 3713; 121 Stat. 1115), to include water conservation as an authorized purpose.



What is the Baseline Feeder?








Baseline Feeder

- In 1990, Valley District, in collaboration with WVWD, City of Rialto and Riverside Highland Water Company, constructed water facilities known as the "Baseline Feeder".
- The System consisted of two wells, a pipeline, and other associated facilities to convey water from the central part of the SBBA to users on the west side of the District's service area.
- In 2010-12, Valley District took the lead to construct the new 9th Street Well Complex, consisting of two (2) new replacement wells, a stilling reservoir, a booster station, and other appurtenances for a complete system.
- The system has been operated by WVWD and functioning as designed since 2012. The capital cost of the system along with the ongoing O&M cost is being paid by the BLF Stakeholders in accordance with the New Baseline Feeder Agreement.





SGIP Equity Resiliency

The California Public Utilities Commission recently created a category in their Self-Generation Incentive Program (SGIP) called Equity Resiliency (ER) that incentivizes batteries for a specified subset of customers that are

- 1) in a low-income or disadvantaged community,
- 2) are at risk of, or have experienced two or more public safety power shutoffs (PSPS) events, and
- 3) are considered 'critical'.

The 9th Street Well Complex meets these criteria.

Through the SGIP, there will be no purchase cost for the batteries themselves, nor will there be any installation fees.



Tesla's Megapack Offer

The incentive program is set up as follows:

- 1) Tesla will receive the SGIP ER rebate payments over 5-years
- 2) The District, on behalf of the Baseline Feeder Stakeholders, will receive ownership of the Megapack system upon installation for \$0.
- 3) Tesla will provide a turnkey installation, operate and maintain the system for 10-years, and provide a 15-year warranty for the batteries.





Benefits to BLF Stakeholders

- Annual electricity bills reduced by more than \$78,000
- Additional emergency backup power during outages (approximately 2.4 hours)
- SBVMWD owns hardware from day I
- Tesla operates and maintains the system
