





Thanks to San Bernardino Valley Municipal Water District's (Valley District) proactive and responsible planning, the District is well equipped with a drought resilient water supply for our service area.

8 million acre-feet of groundwater storage space – more than the entire State Water Project – that is currently over 80% full.





Over 350,000 acre-feet of water stored locally over the last 50 years to help make it through prolonged periods of drought.





\$1 billion invested in the State Water Project since 1972 to supplement local water supplies, allowing us to bank excess water in local groundwater basins.



Even with our diverse water storage projects and programs in our 325-square mile service area, we must all work together to use water efficiently. Over the last 10 years, this region has cut water use by 19% even as the population continued to increase. Regional partnerships help Valley District increase our local, reliable water supply to make sure we have enough water for today and in the future.



Partnering in WATERSHED CONNECT, a multiphase program comprised of interconnected water capture, recharge, storage, treatment, and conveyance projects.



Collaborating with retail water providers on regional projects, such as the Waterman Hydroelectric Generation Plant Project and the Clean Water Factory in San Bernardino, the Sterling Natural Resource Center in Highland, Wilson III Recharge Basins in Yucaipa, and the Cactus Basins in Rialto.



The Enhanced Recharge Project below Seven Oaks Dam enables Valley District, Riverside Public Utilities, and Western Municipal Water District (in Riverside) to capture and store water diverted off the Santa Ana River. This Project will capture up to 500 cubic feet per second and 80,000 acre-feet of water in a single year.



Supporting the water use efficiency efforts of the retail water providers by providing financial incentives for water use efficiency rebates and retrofits, rebates and programs specifically aimed at large water users, and regional landscape workshops and a landscape contest.



Drought







Status Update: October 2021

In the San Bernardino Valley, water supply is a substantial investment of the taxpayers; and Valley District takes its role of managing water resource seriously. This region has been in a drought for 23 years and Valley District prepares for drought every day by securing and managing water resources for the region, regardless of climate conditions.

By taking the proactive position of storing local and imported water supplies in local groundwater basins, Valley District and its retail

water agency partners have established a reliable source of supply that is able to withstand drought. Thanks to the capacity of these basins, the region finds itself in a more favorable position than other cities, retail water agencies, and wholesale water providers around the state.

As of August 23, 2021, San Bernardino County is considered to be under "Extreme" drought conditions. Nonetheless, the drought impact the Valley District service area is low due to the investments and actions noted above. Residents, businesses, and industrial water users should remember the following:



- · Water use efficiency is a way of life in Southern California, especially in San Bernardino County where we average 13.4 inches of rain per year and 280 sunny days.
- Thanks to sound planning and proactive investments, Valley District is well-prepared to meet customer water supply needs even during the current drought.
- · While the region will always be dependent on imported water for some portion of our water supply, we have focused on developing local partnerships, water efficiency programs, and water supplies - such as water recycling, stormwater capture, and surface water storage - to reduce reliance on imported water.
- · Because of this, Valley District is able to quarantee our region the water they need for essential uses such as drinking, bathing, and cleaning.
- · Investments in recycled water infrastructure have made it possible for water providers to reduce reliance on imported water sources.
 - It is a significant high-quality water supply that can be used for multiple purposes;
 - o It is reliable during drought and climate change conditions; and
 - o It requires significantly less energy than imported water for deliveries, thus reducing greenhouse gas emissions.

Clarification on policy regarding Directors speaking on behalf of the Board with outside entities

Staff Recommendation

Representing an Official District Position

In order to ensure that they are properly representing their positions as elected officials of the San Bernardino Valley Municipal Water District, Board members should adhere to the following guidelines:

- 1. Board members may use their title only when conducting official District business, for information purposes, or as an indication of background and expertise.
- 2. Once the Board of Directors has taken a position on an issue, all official District correspondence regarding that issue will reflect the Board's adopted position.
- 3. In most instances, the Board will authorize the President of the Board to send letters stating the District's official position to appropriate legislators.
- 4. No Board member is permitted to attend a meeting of any outside agency or organization as an official representative of the District without prior Board authorization. Meetings of outside agencies and organizations that are included on the District's list of Representative Assignments are to be attended by the designated Board member and/or alternate. Other Directors are not prohibited from attending, but may not participate or request compensation.
- 5. If a member of the Board appears before the meeting of another governmental agency organization to give a statement on an issue affecting the District (including Representative Assignments), the Board member shall indicate the majority position and opinion of the Board. (NOTE: Board members shall report on any actions taken at the next Board meeting).

Representing an Official District Position

- 6.Personal opinions and comments that may be contrary to adopted policy may be expressed only if the Board member clarifies that these statements do not reflect the official position of the Board or the District. To be clear, any Director may speak on any matter as an individual at any time.
- 7.Board members should exercise caution when utilizing the news media, social media or other forms of communications to specifically express views which are in opposition to adopted Board policy. Again, the Board member must clarify that these statements do not reflect the official position of the Board or the District
- 8.When two Board members are authorized/assigned by the Board to attend a meeting as the District's official representative, other Board members may not participate at the meeting in order to avoid violations of the Ralph M. Brown Act.
- 9.Attendance at a water retail meeting, council meeting, or other meeting of an outside agency or organization and reporting on activities or decisions made by the District will not be considered as violating the provisions of the Handbook provided that any reports or discussions either reflect the decisions made by the Board as a whole or are identified as being presented by the Board member "speaking as an individual" and not as the official position of the Board. Qualification for per diem will depend on the specific meeting and whether it is approved categorically or by Board action and will be determined under the District's current adopted Resolution titled Establishing Rules and Procedures for Compensation of Directors and for Reimbursement of Directors and Staff, a current copy of which is included in Appendix 2 of this Handbook.
