





 - > Benefits:
 - Cost County Parks Contract, reduced contracting fees, encampments
 - Safety Encampments
- Finalize USACE permitting in parallel

HCP Update - Mitigation



SARCCUP Grant

- Pursuing amendment (+ OCWD, WMWD)
 - > Time extension (construction): September 2023 to March 2025
 - > Benefit Adjustment
 - 3.5 stream miles reduced to 2.8 stream miles
 - 40 acres riparian habitat increased to 60 acres riparian habitat



HCP Update - Mitigation




Evans Lake Tributary Restoration and Camp Evans Wilderness Park

- > Prop 1 grant: \$6 million (\$2 million in grant funds, \$4 million in cost share)
- > Partner: City of Riverside Parks and Recreation
- > Grant requirements:
 - > 1.4 miles of stream
 - > 100 acres of aquatic, riparian, upland habitat
 - > 65 acres high-quality riparian habitat
 - Conservation easement
- > CEQA & Permitting to be completed by October 2022
 - ➤ Not yet added to the Agreement with DWR



Lake Evans





City-owned land

BUT

- Flood Control Easement
- USACE levee
- Recreation components, fire requirements
- Habitat enhancement, stream habitat - increase in T&E species
- Conservation easement language strict, cannot accommodate incompatible activities

HCP Update - Mitigation



Evans Lake Tributary Restoration and Camp Evans Wilderness Park

- ➤ Without mitigation credit from Wildlife Agencies, cannot justify \$4 million in cost share
- ➤ Unable to meet the grant objectives
- > Proposing to withdraw project from Prop 1
 - Accomplished via a letter (no agreement in place)

- > Finish CEQA
- Additional funding sources

SNRC Conservation Actions

- ➤ Nonnative aquatic species control plan
- ➤ Cooling water Rialto Channel
- >Translocation of Santa Ana sucker
- ➤ Mainstem microhabitat:
 - Less intensive (HREA program)
 - Intensive 3 locations selected, designs in preparation.
 - Potential partnership with USACE on largest project

ALLUVIAL SCRUB AREAS

- ➤ Started habitat management at three sites
- ➤ Section 6 funding for land acquisition
 - Acquisition of two parcels in Lytle Creek
 - ➤ Received willing seller letters
 - >\$3 M from USFWS
 - >\$1 M from WCB





Tres Lagos Property







Location

- City of Highland, northeast of Redlands and Mentone
- Adjacent to the confluence of Mill Creek and the Santa Ana River (Seven Oaks Dam is to the north)
- Adjacent to San Bernardino National Forest
- Approximately 1,650 acres
- Purchased via Auction from OC Flood



Adjacent Open Space

- Contiguous with large blocks open space
- Corridor between SBNF and Crafton Hills







Existing Water Infrastructure

- Pipelines owned and operated by SBVMWD
- Tres Lagos Mutual Water Company pipelines and appurtenances (tank, wells)
- Bear Valley Mutual Water Company pipeline (a.k.a. Bear Valley Highline)





Habitat

- Multiple habitat types
- Currently in degraded condition
- U.S. Fish and Wildlife Service designated critical habitat for San Bernardino kangaroo rat
